SPEAKER



Dr. Jim C. Weir is a native of Meridian, Mississippi. He graduated from Millsaps College in 1971 with a B.S. in biology. He received his D.D.S. degree from the University of Tennessee College of Dentistry in 1974. He completed residency training in Oral Pathology at Emory University School of dentistry in 1976. He also earned a J.D. degree from Loyola University School of Law in 1985.

From 1976 to 1980 he served on the faculty at the University of Mississippi Medical Center as Assistant Professor of Pathology and Oral Pathology. In 1981 he accepted the position of Associate Professor and Head of the Department of Oral Pathology at the Louisiana State University School of dentistry. He later served as Professor and Head of the Department of Oral and Maxillofacial pathology and Assistant Dean for Admissions at LSU. In January, 2010 he joined the faculty at William Carey University College of Osteopathic Medicine as Associate Dean for Student Affairs, and Professor of Pathology, Histology, and Oral Health.

Dr. Weir is a Fellow of the American Academy of Oral and Maxillofacial Pathology and a Diplomate of the American Board of Oral and Maxillofacial Pathology. He is a member of the American Dental Association, Louisiana Dental Association, Northlake Dental Association, Pierre Fauchard Academy, and the Eastern Society of Teachers of Oral Pathology. In addition to his teaching and administrative duties, he has been actively involved in the practice of Oral and Maxillofacial Pathology, serving as Director of the Oral Pathology Biopsy Service at the LSU School of Dentistry.

During his career, Dr. Weir has authored 31 scientific articles and abstracts in National or International journals. He has presented over 400 continuing education lectures on a local, state, and national level. He has also been the recipient of eleven "Teacher of the Year" awards from his students.

Dr. Weir's major activity outside his profession is participating in triathlons and master's track meets. He is also active as an NCAA official in track & field. He and his wife, Nancy, currently reside in Covington, LA. They have four children: Christie, Marcie, Abby and Katie.

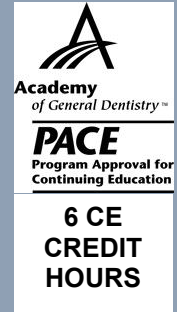
